Lease contract

The undersigned:

Aktie-Shop.EU B.V. (kvk: 64121496), having its registered office at 3316 GZ, Pieter Zeemanweg 121 in Dordrecht, legally represented for this purpose by J. Kraak e/o R. Diemel, hereinafter referred to as the Lessor;

And

Name with initials according to your email and living at the address indicated by you, hereinafter referred to as the Lessee;

Considering:

- that the Lessee wishes to obtain for private use the disposal of a the pram as ordered by the Lessee, the confirmation email includes the unique serial number.
- that the Lessee has reached an agreement with the Lessor regarding the lease of the above-mentioned children's car and the Lessor is willing to give this children's car (hereinafter to be referred to as: the lease object) in use by the Lessee under conditions to be stated below.
- The identity of Lessee has been established through the acceptance of this lease agreement and Lessee declares that this has been done truthfully; and will promptly notify Lessor of any change; You have received a unique ID upon confirmation of your order.
- The identity of the Lessee will be established by a combination of name, address and customer number; The Lessee has a unique ID number starting with CUS:......

Have agreed as follows:

Article 1

- 1. The Lessor provides the Lessee with the same use as the Lessee receives from the Lessor, with effect from the time at which the pushchair is fully assembled, tested and made available to the Lessee ready for use. Delivery and assembly will be at the expense of the Lessor.
- 2. This agreement is only final once the Lessee has fully and unambiguously agreed to it. Previously made offers do not bind the Lessor.

Article 2

- 1. This agreement is entered into for the period requested in the email, expressed in months. During this term, the agreement can only be terminated in writing against the last day of the aforementioned period, with due observance of a notice period of one month.
- 2. After the end of the months referred to under 2.1, this agreement will be extended indefinitely. In that case, either party may terminate the agreement in writing with due observance of a notice period of one month, at the end of a calendar month.

Article 3

The price for the commissioning and the other services and performances made available and to be made available by the Lessor to the Lessee is the agreed amount per month (the lease price). The Lessor only accepts payments by credit card; the Lessee is obliged to ensure that the Lessor can collect the lease price from the Lessee's credit card each time no later than the 1^e day of each calendar month. Only with the written consent of the Lessor can the parties agree on another method of payment.

Article 4
